



## Wednesday February 7<sup>th</sup> Free Cinnamon Donut Giveaway Terms & Conditions

1. Participation in the promotion is deemed acceptance of these Terms and Conditions.

### Promotion Period

3. The Promotion commences at 7 February 2024 at 12am (AEST) and concludes at 7 February 2024 at 11.59pm (AEST). However may conclude earlier in the event that allocated stock of the Promotion is exhausted.

### Terms of Promotion

4. Each customer who presents at the counter of a participating Donut King store is entitled to claim one (1) free cinnamon donut (the **Promotion**) during the Promotion Period.
5. All customers seeking to claim the Promotion must be present at the participating Donut King store.
6. The Promotion is not transferrable.
